



DIBROM® CONCENTRATE and TRUMPET® EC 2023 NATIONAL DRUM RETURN PROGRAM

Through our **AMGUARD Environmental Technologies** product stewardship program, **Container Services Network (CSN)** manages all returns of your empty **DIBROM® CONCENTRATE** and **TRUMPET® EC** drums. This is a premium service provided at no additional cost to you. The following instructions are provided to assist you in this process. As always, we thank you for your cooperation and your trust in AMGUARD Environmental Technologies products.

LTL Carrier Requirements Update

Carriers are no longer accepting/loading double stacked pallets or loose drums. This change is consistent with most LTL carriers across the country. The effort is to improve handling and load configuration to aide routing efficiencies. Please refer to the following requirements and instructions to ensure a smooth drum return experience:

1. Each drum must be empty and weigh 29 lbs., or less, with all openings securely sealed.
2. Please have a minimum quantity of eight (8) drums before scheduling your return.
3. Wrap drums securely to each pallet.
4. Stage drums for safe access and loading.



Returns of 8 or more empty drums must be staged and securely wrapped on a single (un-stacked) pallet.

When is a drum considered empty?

DIBROM® CONCENTRATE and **TRUMPET® EC** are delivered in blue 30-gallon HDPE closed-system drums. Each drum is filled according to production weight to ensure a minimum dispensable volume of thirty gallons. Once empty, each drum should weigh < 29 lbs. Four (4) empty drums on a standard pallet will weigh approximately 180 lbs. Please confirm all drums are empty and properly sealed to avoid additional return and/or disposal fees.

Step #1

Send an email to logistics@containerservicesnetwork.com. Include the quantity of drums being returned, a detailed pick-up address, hours of operation for receiving trucks and a mobile contact number where the driver can reach you.

Step #2

CSN responds to all drum return emails within 48 hours. A member of the CSN team will update you by email and include a copy of your Bill of Lading (BOL). Once received, please review all details on the BOL for accuracy.

Step #3

PRINT the BOL and provide it to the driver upon arrival. The availability of preferred carriers varies daily. We appreciate your patience during this process and feel free to contact us with any questions or concerns.
